Renewal of Annual Licences through the Online Submission Platform

1. Due date for renewal of licenses

The Financial Services Commission (the "Commission") hereby reminds all Licensees/Registered/Authorised/Approved persons who are required to pay their annual fees that the due date for payment of the 2021/2022 annual fees is **1st of July 2021**.

2. Quantum of fees

The quantum of fees payable is specified in the Financial Services (Consolidated Licensing and Fees) Rules 2008, as amended.

3. The Online Submission Platform (the "OSP")

Licensees will be able to pay their fees, as well as, the fees of the licensees of the Commission (i.e. their clients) by logging in to the OSP as from 01 June 2021, by way of *Electronic Funds Transfer (EFT)*. Management Companies, which have *Deposit Accounts* with the Commission, will also be able to pay their fees from their respective Deposit Accounts. We trust that, despite the constraints arising as a result of the Covid-19 pandemic, these arrangements will ease the existing process to ensure that renewal of licenses are done within the deadline.

Licensees can log in to the OSP as follows:

- i. Click on the following link: <https://www.osp.fscmauriti.us.org/> in the URL of your browser's navigation bar and press "Enter" on your keyboard.
- ii. Licensees who have not yet registered with the OSP will need to register at earliest possible. Respective Personal Identification Numbers (PINs) will be issued further to the completion of the registration.

- iii. Global Business Companies should opt for Renewal of Global Licences.
- iv. Non Global Business Companies should opt for Renewal of Domestic Licences.

4. Alternative arrangements to OSP

Should licensees encounter issues in renewing licenses through the OSP, they may use the alternative method established by the Commission which will allow prompt renewal of licences, as follows:

- a. Send the relevant amount by bank transfer ensuring the funds are received at our Bank by the due date. The Bank's details are as per Annex 1;
- b. Send an excel copy of the relevant list(s) for which the payment is being made to the following email address: ospfinance@fscmauritius.org.

5. Other important information
